She has continued to develop this topic which has been invaluable to her work as a psychologist, as a parent and an educator in developing applications of ethics education in various settings.

CONFERENCE PRESENTERS IMPOSSIBLE WORLD

Your presentation on trauma was captivating and impactful. It will greatly improve my ability to work with trauma clients. It was a very affective and touching presentation.

Ralph Wechsler, Ph.D.'s interests in psychosis, psychological trauma, and suicidal behavior started while working on an emergency psychiatric service during his graduate training at the University of Colorado at Boulder. In 1983, he completed his doctoral dissertation with Dr. Peter G. Ossorio, on the relationship between personality characteristics and manic states. After his graduate training, he worked primarily in inpatient settings, including a long-term inpatient unit that focused on psychotic disorders or complex personality disorders. At the Denver V.A. Medical Center, Ralph has continued working with psychotic disorders as well as posttraumatic stress disorder. He has served as the Director of Psychology Training and Director of Inpatient Mental Health Services. Ralph is currently the Aftercare Coordinator for the PTSD Residential Treatment Program at the Denver VA. In addition, he has maintained a diverse private practice and is on the faculty in the Department of Psychiatry at the University of Colorado. Ralph has presented on psychological trauma to a variety of audiences, including lawyers being training on mitigation issues in death penalty cases by the Colorado Alternate Defense Counsel, combat veterans and their spouses in the National Guard's Post Deployment Reintegration Program, law enforcement personnel at the Denver VAMC, and students from the University Of Denver Graduate School Of Professional Psychology.

Ryan E. Breshears, PhD is a licensed psychologist with a doctorate from the University of Georgia. Ryan is Director for Psychological Services with Well Star Health System, a 5-hospital integrated health network in metro-Atlanta. Ryan oversees program development including the integration of Health Psychology and Behavioral Health services across primary and specialty care services. He serves as an Adjunct Assistant Professor at the University of Georgia. Ryan completed a postdoctoral clinical research fellowship with the Veterans Integrated Service Network located at the Denver VA Medical Center. As an implementation science researcher, he was a key facilitator in the implementation of the Self-Directed Violence Classification System devised by the Denver VA and Centers for Disease Control and Prevention. He has published in several journals in the area of suicide prevention.
